- (a) As per instruction issued by the Chief Engineer, P.W.D. Rajasthan. Jaipur vide his letter No 902 dated 1-6-88 it will be obligatory on the part of the contractor to use following departmental machinery on works. The Hire Charges for machinery shall be as per list enclosed.
 - (b) Use of privateer owned or privately hired machinery on contractors work can only be permitted after receipt of N.A.C. from the executive Engineer, Mechanical Division-II, Jaipur/ Executive Engineer, Incharge of the work.
 - (c) Each private machine will have a authorised Log Book issued by concerned Executive Engineer along with issue of certificate as specified above.
- The recovery rate of cement is inclusive of cost of jute or paper bages. The contractor shall 2. have to return at least 75% of the cement jute bags in serviceable conditions to the bag collecting agents. The payment for the cost of the empty bags will be made to the contractor by the bag collecting agents at the prevailing rate fixed by the D.G.S.& D. The contractor shall get the name of the Collecting Agent from the Engineer-In-Charge in writing. The contractor must produce the certificate on the printed letter head from the authorised bag collecting agents as proof for the number of bags in serviceable conditions return by him, This certificate must be produced by him while claiming payment against each running bill. In case the number of serviceable bags returned in less than 75% of the bags issued compensation at the rate Rs. 1/- (one) per bag returned short of the minimum number shall be recovered from the contractor. In case empty cement jute bags are requieted by P.W.D. for benefit use in works the Engineer-In-Charge of the work shall have powers to comment the bags and the contractor shall have to return the desired number of empty jute bags in serviceable conditions to him to the same condition as for bag collecting agents, the contractor shall send registered intimation to the bag collecting agents of the cement factories for collecting the bags within a period of 20 days. If the bag collecting agents fail to turn up within the stipulated-period, the contractor shall be deliberate to dispose off the bags.
- The contractor shall return the unused material issued to him by the department and in case failure to do same shall be charged for such unreturned material double the issue rate including storage and Supervision charges or the market rate which ever is higher. The contractor shall also be charged for the material consumed in excess of requirments calculated on the basis of the critical consumption at double the issue rate including storage and supervision charges or market rate whichever is higher.
- 4. If their is any typographical clerical error or otherwise in the 'G' schedule, the rates as given in the B.S.R. of circle/Department for the area on which schedule 'G' has been prepared shall prevail.
- 5. The Government shall have right to cause and audit technical examination of the work and the final bill of the contractor including all supporting vouchers, abstracts etc. to be

made within 2 years after payment of the final bill if as a result such audit and tecrimic examination any sum is found to have been over paid in respect of any work done by contractor under the contract or any work claimed by him have been done by him under the contract and found not be have been executed, the contractor shall be liable to refunc the amount of over payment and it shall be lawful or the department to recover the sum from him in the manner prescribed in special condition No......or in any other manner legally permissible.
