एतद् द्वारा सर्व साधारण को सूचित किया जाता है कि निर्माण एवं विध्वंस अपशिष्ट (Construction & Demolition Waste) प्रबंधन नियम-2016 के नियम 4 (5) की पालना में निगम द्वारा मलबा संग्रहण एवं परिवहन हेतु निम्नानुसार शुल्क निर्धारित किया गया है :-

For Bulk Waste Generators -

For Bulk Waste Generators: Segregated C&D Waste- Rs.600/- per Ton

For Bulk Waste Generators: Non-Segregated C&D Waste- Rs.1000/- per Ton

For Non-Bulk Waste Generators:-

Tractor Trolley

Capacity- Upto-100 Cub Fit – Rs. 1200/- per Trip

Mini-Truck

Capacity- Upto-150 Cub Fit– Rs. 2000/- per Trip

Dumper/ Truck

Capacity- Upto-625 Cub Fit – Rs. 5000/- per Trip

-Rs.10000/- per default (First default) + Additional charges for collection, transportation and processing

-Rs. 25000/- per default (Second default) + Additional charges for collection, transportation and processing

-Rs. 100000/- per default (Third default) + Additional charges for collection, transportation and processing

Public Notification
C&D Waste User Charges and Penalties

As per Construction and Demolition (C&D) Waste Management Rules 2016, processing of C&D waste is mandatory for all ULB's. It is the duty of every waste generator to keep the construction and demolition waste within their premises and directly load the C&D waste to Municipal Corporation's vehicle or get the waste deposited at collection centre so made by the Municipal Corporation and ensure that there is no littering or deposition of construction and demolition waste.

Nagar Nigam Greater Jaipur (NNGJ) and Nagar Nigam Jaipur Heritage (NNJH), in accordance with Rule 4(5) of the Construction and Demolition Waste Management Rules, 2016 issued by the Ministry of Environment, Forest and Climate Change, Government of India, is fixing the Rates of User Charges for Bulk Waste Generators (20 tons or more in one day or 300 tons or more per project in a month) and Non-Bulk Waste Generators (less than 20 tons in one day or up to 300 tons per project in a month) within the limits of Nagar Nigam Greater Jaipur and Nagar Nigam Jaipur Heritage as per Annexure "A" "B" and "C".

Rates of User Charges from C&D Bulk Waste Generators and Non-Bulk Waste Generators

For Bulk Waste Generators

Sr.No.	Type of C&D Waste	User Charges
1	Bulk Waste Generator: Segregated C&D Waste.(.)	Rs. 600/- per Ton
2	Bulk Waste Generator: Non-Segregated C&D Waste	Rs. 1000/- per Ton

For Non-Bulk Waste Generators

Sr.No.	Type of Collection Vehicle	Rates of User Charges
1	Tractor Trolley Capacity - Upto-100 Cub fit.	Rs. 1200/- per Trip
2	Mini-truck Capacity - Upto - 150 Cub fit.	Rs. 2000/- per trip
3	Dumper/Truck Capacity - Upto - 625 Cub fit.	Rs. 5000/- per trip




Charges for Registration of C & D or remodelling work from all individuals and organizations

S. No.	Registration	Registration Charges Fee per Work
1	Every C&D Bulk Waste Generator and Non-Bulk Waste Generator has to be registered in respective Nagar Nigam i.e, Nagar Nigam Greater Jaipur and Nagar Nigam Jaipur Heritage	Registration Charges shall be 100/- per registration and shall be valid for 6 months from the date of start of registration

Note: - If registration is not done by Generators, then spot fine of Rs. 1000/- is to be imposed and collected by SI/CSI/DC/CHO/Officers or from Building Planning & License Section or any other person authorized by NNGJ & NNHJ.
